

**Subject:- GRANT OF ALLOWED TO WORK STATUS IN FAVOUR OF M/S. WING FOR THE AWARENESS & DEVELOPMENT OF DIR AREA NATIVES (WADDAN), - A PESHAWAR-BASED NGO.**


I am directed to refer to the CAR Khyber Pakhtunkhwa letter No. ACR(S)/22/AR/16, dated the 25<sup>th</sup> January, 2012 and to convey approval of the Ministry of States & Frontier Regions to the grant of "Allowed-to-Work" status in favour of M/S. Wing for the Awareness & Development of Dir Area Natives (WADDAN), a Peshawar-based NGO to work for the welfare of Afghan Refugees in Khyber Pakhtunkhwa with effect from 31-01-2012 subject to fulfillment of the following conditions:

- i. The NGO will not enlist the unregistered NGOs as its members in Pakistan.
- ii. The NGO will abide by all Government directives/policies/instructions/rules & regulations regarding the NGOs in Pakistan with sound reputation; to be verified by the Scrutiny Committee (of the Commissionerate for Afghan Refugees (CAR), Khyber Pakhtunkhwa).
- iii. The NGO will not use Wireless Equipment without valid license/permission.
- iv. The NGO will not employ foreign nationals without permission.
- v. The NGO will provide gratis facilities to the Afghan Refugees.
- vi. The NGO will work in collaboration/coordination with Commissioner Afghan Refugees, Khyber Pakhtunkhwa for the welfare of Afghan Refugees.
- vii. The NGO will furnish quarterly/annual reports of activities to the CAR, Khyber Pakhtunkhwa regularly under intimation to this Ministry as well as the Chief Commissioner Afghan Refugees (CCAR), Islamabad.
